

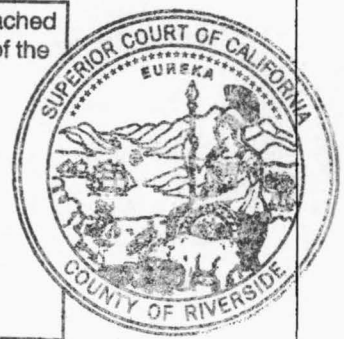
(ii) \$158,812.75 in attorneys', paralegals', and auditors' fees, and actual costs, to the Attorney General.
